### Conditions Relevant to Koliyabandara Educational Trust Fund (KETFund) Awards

The following requirements and conditions are applicable to be entitled for the Scholarship and to receive Scholarship installment payments within the academic duration.

• Scholarship installments will be paid monthly based on the progress made by the scholarship recipient on studies for which the scholarship is awarded.

o For university scholarships, scholarship installments will be a maximum amount of Rs. 5,000/- per month subject to a maximum of 10 installments per an academic year.

- Monthly payment will be directly credited to the bank account of the scholarship recipient by the Trust Fund. Recipients will be required to open an account with a Bank of Ceylon branch.
  - o It is required to attend, properly, for the lectures, tutorial classes, and practical classes prescribed for the course and to have an 80% attendance. In situations contradictory to that, scholarship payments will be suspended in accordance with the recommendation made by the university in that regard.

o Only one installment per month during the period of conducting the course will be paid to the scholarship recipient.

- o In case the student becomes eligible for another scholarship for the same course of studies or any other course of studies, he/she will have to inform us immediately. Upon such instances, the Trustees will carry out a fresh evaluation and determine whether the scholarship should continue with the same award or decide to reduce the award or cancel the award completely.
- The Scholarship will be canceled in below mentioned situations. Appeals submitted in that regard also will not be considered.
  - o Non attending the course.
  - o Long term absence from the course.
  - o Failure in annual exams
  - o Abandonment of the study course.
  - o Class suspension due to disciplinary matters
  - o Receiving punishments with regard to ragging
  - o At an instance where a student has been punished after a disciplinary inquiry conducted by the university for offenses on act of misconduct, delinquency or abuse or when punished by a court for other offenses.
  - o Receiving punishments for damaging university or public property.
  - o The reasons of engaging in a business, service or employment for generating income will be caused for the discontinuance of the scholarship installments and eligibility.
- In the event of a student obtaining permission for postponement of his/her studies in unavoidable and uncontrollable circumstances, if he /she wishes to receive this scholarship in the next relevant year, the student should obtain prior permission from the Trust which should carry the recommendation of the Registrar of the University.
- The Trust Board will obtain information/reports from the Registrar of the academic progress and conduct of the student from time to time and if such reports are not satisfactory or contravene to any of the conditions stated here, the Trust Board will review and cancel the scholarship if the student is found be guilty of not complying with the conditions laid down.
- The decision of the Trust Board of the Koliyabandara Educational Trust Fund (KETFund) regarding scholarships or scholarship installments will be treated as final.
