If you would like to participate in the study, we will ask you to provide your consent and will then arrange to complete a brief 15-20 minute interview with you.


We will ask you to about your child's details including, birth and medical history, family history and other relevant details. If you decide you do not wish to participate you can stop the interview at any time.

After the interview, we may seek any missing information from your or your child's doctor/therapist and/or through access to your health record.

Information on your child will be kept in the Sri Lankan CP Register, a secure web-based database. A deidentified copy of CP register data will be shared with the Australian CP Register for future research.

#### 3. Potential benefits or risks of participating

There are no immediate direct benefits resulting from participation in this study. Joining the CP register will however provide you with opportunity to be contacted regarding research trials for new interventions that may be developed in the future.



The data you provide will form part of a large dataset that will help researchers learn more about CP in Sri Lanka. This data will be used to raise awareness about CP and to identify causes and prevention strategies for CP.

Beyond providing your valuable time for the interview, there are no significant risks involved with participating in this study.

#### 4. Reimbursements

There will not be any payment for participation in the study.

## 5. Confidentiality

The interview will be held in a convenient separate meeting space or by telephone to ensure your privacy. Your child's information will be stored securely and no information by which you or your child can be identified will be released, published or presented.
